USE OF CEMETERY

The main entrance gates shall be opened at 7:00 a.m. daily and shall close at 5:30 p.m. from November through March and 7:30 p.m. from April through October.

Authorized persons shall enter the cemetery grounds through the main entrance gate during visiting hours only. Recreational use of the cemetery grounds is prohibited.

All persons and organizations entering or effecting upon the Cemetery premises shall abide by the Rules and Regulations.

All personal and/or group conduct and decorum shall maintain an appropriateness consistent with the purpose of the Cemetery as determined by the Association.

All persons shall be prohibited from plucking flowers, or shrubs, either wild or cultivated, injuring trees, defacing monuments, markers, images, fences, or in any way interfering with the easement rights of others. All persons detected violating this rule shall be prosecuted to the full extent of the law.

All pets shall be prohibited in the Cemetery.

Vehicles, including motorbikes and motorcycles, shall be operated only on established roadways and at a speed not in excess of 15 miles per hour.

Use of common courtesy when parking autos shall be mandatory. Cars shall be parked only on one side of roadways in the Cemetery grounds at any time. On Easter Sunday, Memorial Day, and All Souls Day, no cars shall be parked on either side of any roadway which serves as an entrance to or exit from the Cemetery. The Association reserves the right to remove all cars improperly parked.

No vehicle or trailer shall be driven or hauled off of a hard surface roadway at any time.

Artificial wreaths, flowers, crosses, ornaments and designs shall be permitted after November 20th and shall be removed beginning March 1st of the following year.

Statuary or a decoration other than floral which is not part of a monument design, benches, baskets, crockery, glass, wire, wrought iron, and metal receptacles, vigil lights, shepherds' hooks, wood chips, marble chips, windsocks and other items detrimental to the appearance of the Cemetery are not permitted by the Association and shall be removed without notice. Attaching decorations to trees shall be strictly prohibited.

Flags and flag holders shall only be permitted to be placed next to a memorial on Memorial Day, Independence Day and Veterans Day. Both shall be removed by 10 days after these Holidays.

Plants or shrubs next to markers shall not be permitted. Planting of approved shrubs at each end of a monument representing three or more graves shall be permitted, in designated areas only, with written consent of the Association.

Planting of live flowers around the base of a monument shall be permitted, with the consent of the Association.

No curbing, fencing, hedging, borders or enclosures of any kind shall be allowed and the same shall be removed if so erected, planted or placed.

Cut flowers in approved containers shall be permitted at any time. Artificial flowers and potted plants shall be permitted on Easter, Memorial Day, and All Souls Day. All such flowers and plants shall be removed by the Association when mowing or trimming grass or in ten (10) days after the holiday or holy day. On other special days, such as

Mother's Day, Father's Day, St. Patrick's Day, etc., decorations shall remain 3-5 days according to necessary lawn maintenance. All decorations shall be placed on the lawn, not dug into the turf.

Floral pieces, baskets and other articles placed on a grave following a burial shall be removed on a regularly scheduled basis or as they become wilted or unsightly. Relatives desiring to retain any such items should remove same immediately following the committal service. The Association shall not be responsible for any such items.

Trees shall be permitted in designated areas only, with the written consent of the Association.

The Association shall have the right, from time to time, to plant, transplant, remove or prune trees, shrubbery, or plants, throughout the Cemetery.

Throwing of rubbish on roads, driveways, paths, walks, or any part of the grounds or in the buildings shall be prohibited. Baskets shall be provided throughout the Cemetery for refuse.

No signs, notices or advertising of any kind shall be allowed in the Cemetery, except those placed by the Association.

Calvary Cemetery belongs to all the people of our Catholic Community.

Its operation is governed by trustees from each parish in our community who serve without pay. They give their time and talent as a community service.
